



## **Privacy Policy**

Here at Athlone Golf Club we take your privacy very seriously and will only use your personal information to allow us to fulfil our contractual obligations to you as a member/visitor in accordance with our club's articles/rules/constitution.

### **What information do we collect about you?**

Visitors please be advised that each time you visit our Website, two types of information about your visit can be retained. The first type comprises of statistical and other analytical information collected on an aggregate and non-individual specific basis of all browsers who visit the site. The second type of information is personal or particular to a specific visitor who knowingly chooses to provide that information.

Through our Website you may have an opportunity to send us information, such as through the "membership request" page or any other area where you may send e-mails, etc. By choosing to participate in these, you will be providing us with some level of personal information relating to you.

### **Legal basis for collecting data.**

When you join or visit our Golf Club we collect only the information required from you to fulfil our contractual obligations. We may also collect further information which allows us to contact you regarding events and offers at the club provided you have opted in to receive this information.

As an employee of the club we collect only the information required to fulfil the contractual relationship between you and the club. We only share your data with our internal and external data processors where it's required to fulfil the contractual relationship.

Athlone Golf Club encourages you to review the privacy pages you choose to link to from Athlone Golf Club so that you understand how those web sites collect, use and share information.

### **How the information about you will be used.**

When you join as a member, or enter into a society event, or an open competition, your information may be shared with internal or external data processors for the purposes of fulfilling our obligations in relation to all activities that relate to handicap, competition, and membership administration (ClubV1, BRS etc. Membership Administration System). Your personal data is controlled internally by the clubs Data Protection controller who adheres to the Golf Club's internal data protection policies and procedures.

### **Marketing**

You may have opted in for correspondence with you regarding our activities that include events and competitions by way of post, telephone, email and SMS. We don't share your

data with external marketing companies who would contact you in this way. If you have consented to this correspondence you can opt out at any time.

### **Individuals Rights**

You have the right to request a copy of the information we hold about you. If you would like a copy of this information please email us on [athlonegolfclub@gmail.com](mailto:athlonegolfclub@gmail.com) or write to the data controller at the club.

We want to make sure that your personal information is accurate and up to date. You may ask us to correct or erase information that you think is inaccurate.

At the time of collecting data you have the right to object to the club holding certain information about you.

### **Where we store your personal information**

We store the information we collect about you on our secure servers. Any hard copy information is secured from unauthorised access.
